## Who are we looking for?

We are seeking to recruit a Safety, Health, Environmental & Quality (SHEQ) Advisor, to join our thriving and growing environmental consultancy. This is an exciting opportunity to support TEP's Health and Safety function across the organisation and the operation, implementation, and development of TEP's Integrated Management System (ISO 9001, ISO 45001 & ISO 14001).

You will take an active part in projects, campaigns and initiatives to keep our workforce safe and healthy and save lives on construction sites.

The SHEQ Advisor will join TEP's People, Quality and Development team (PQD) based in our head office, Warrington, supporting our business nationally.

This is an exciting and interesting opportunity for someone who is passionate about making a positive difference to the environment, whilst seeking to continually develop and be fully supported on their SHEQ career pathway.

## **Role and Requirements**

As a SHEQ Advisor you will work as part of our SHEQ team supporting SHEQ compliance, advice and ensure guidance with legislation and industry best practice. You will take steps to ensure accident prevention and safe working practices for our office environments and whilst staff are carrying out field surveys or site inspections.

You will work closely with our H&S Manger in developing our health and safety management systems, ensuring that policies, procedures and risk assessment method statements are kept up to date, and compliant with relevant best practice and legislation.

The role will be varied enabling you to work with colleagues across the organisation. This will primarily be delivered by supporting our H&S Manager and Training and Quality Manager in undertaking internal audits, on-site inspections and reporting on SHEQ performance for business operations, office and field based surveys.

We will support you in being able to identify concerns or trends for the future and contribute to a strategy for improvement for SHEQ activities.

The successful candidate will be based in Warrington but on occasion may be expected to travel from time to time, including staying overnight at different locations, visiting our other offices and completing on site audits.

### Qualifications

We will be interested to hear from applicants who hold or who are working towards a recognised H&S qualification such as, NEBOSH General Certificate, IEMA Foundation or equivalent and/or working towards Tech IOSH/Grad IOSH or other relevant health and safety qualifications. (TEP will support working towards relevant qualifications, upon successful completion of the probation period).

## **Experience**

- Some experience working within the construction industry, including delivery of internal audits and inspections would be beneficial but not essential.
- Knowledge and understanding of the requirements of and Integrated Management System (ISO 45001, ISO 9001& ISO 14001) and the audit process.
- Knowledge and experience of H&S matters including legislation, best practice and ability to assist with internal investigations of alleged H&S breaches.
- Experience in maintaining and developing SHEQ records, database, calibration of equipment would be beneficial but not essential.
- A good understanding of relevant environmental legislation.
- Confident liaising with colleagues and supporting them in SHEQ matters
