Who are we looking for?

We are seeking highly motivated, experienced ecologists over a range of grades to join the TEP Ecology Team in our Warrington, Gateshead or Market Harborough office. This opportunity will appeal to ecologists with at least 3 years experience, looking for a consultant, senior or principal role and we are particularly interested in candidates who have technical skills in at least one of the following: botany/habitat surveying; biodiversity net gain; bat ecology (Level 2 bat licence holder); and ornithology.

You will work with a broad range of clients and development sectors across the UK which includes residential, urban regeneration, utilities infrastructure, commercial and leisure developments as well as projects associated with BNG off-site delivery, green infrastructure, conservation and restoration schemes and strategic level projects.

❖ Have FISC Level 4 or above and proven experience of higher level botanical surveys such as NVC, hedgerow, UKHab and BNG habitat condition assessment is desirable
❖ Demonstrable experience in BNG assessment including use of the Metric and developing habitat enhancement, creation and management strategies is desirable
❖ Experience of Scottish ecological legislation is desirable for candidates working from Gateshead
❖ Holds a protected species licence (particularly a Level 2 bat licence), and has experience of designing and delivering licenced mitigation schemes is desirable for Senior and Principal positions
❖ Experience producing a range of written assessments including desk based studies, technical reports, Preliminary Ecological Assessments and Ecological Impact Assessment
❖ Experience authoring ecology chapters of Environmental Statements and/or HRAs is desirable for Principal positions
